



DEADLINE FOR SEXUAL HARASSMENT POLICY UPDATE

As recently discussed at the IAPD Legal Symposium, the deadline is fast approaching to update your agency's sexual harassment policy to address one of the changes in the new Workplace Transparency Act, **SB 75 / Public Act 101-0221**.

As reported in our Legislative Updates earlier year, all local governments must adopt an ordinance or resolution amending their existing sexual harassment policies to incorporate a mechanism for reporting and independent review of allegations of sexual harassment made against an elected official of the governmental unit by another elected official of a governmental unit.

Existing policies that address harassment in the employment context may not cover this very specific circumstance of alleged harassment by one elected official against another because elected officials are not employees.

While there is no one-size-fits-all solution for this new requirement, one alternative discussed at the Legal Symposium is to incorporate a process like the following into the district's existing harassment policy.

"Alleged harassment by a commissioner against another elected official can be reported to the Board President. If the Board President is the reporting person or is implicated by the allegation, the report can be made to any other commissioner. Any report under this

section must be referred to the district's legal counsel, who then must appoint a qualified independent attorney or consultant to review and investigate the allegations."

As is the case with any changes to the district's policies and procedures, this suggestion and any modifications to it should be reviewed with the agency's local counsel.

Units of local government have until **February 9, 2020** (6 months from the effective date of this portion of the new law) to amend their harassment policy.

Another section of the new law will require all Illinois employers to provide sexual harassment training to their employees beginning next year. The Illinois Department of Human Rights (IDHR) is required to make a model sexual harassment training program available for employers to satisfy the training requirement. Employers may also establish and utilize their own sexual harassment prevention training program, but it must equal or exceed the state's minimum state standards.

The IDHR has not yet made its program training available, however, we will update you as additional information becomes available. It is important to note that the annual training requirements do not begin to take effect until 2020.

These and many other legal and legislative developments will be discussed in greater detail during Legal/Legislative Part I #110 and Legal/Legislative Part II #111, at the Soaring to New Heights Conference.

DOR Proposes New Parking Excise Tax Rules

In order to fund the new Rebuild Illinois capital bill, lawmakers approved a series of new taxes and fees earlier this year. One of those taxes is a "Parking Excise Tax" to be assessed on the use of paid parking spaces in certain parking areas or garages.

The Illinois Department of Revenue (DOR) recently proposed new rules to implement this new parking excise tax. These proposed rules clarify that this new tax does not apply to parking areas or garages that are owned and operated by a unit of local government with an active DOR tax-exempt number. However, if the parking area or garage is owned by the local government but operated by a third party through a lease or other contractual arrangement, the third party that contracts with the unit of government to operate the parking area or garage would be responsible for collecting and remitting the tax.

Examples of the application of the tax are outlined in the proposed rules. DOR has also issued an Informational Bulletin with specific guidance.

General Assembly Approves New Legislation Impacting All Public Employers with Union Contracts

During the fall Veto Session, the General Assembly approved amendments to the Illinois Public Labor Relations Act to add several new mandates for public employers.

If signed by the Governor, **SB 1784 (Harmon, D. /Hoffman, J.)** will:

- Require an employer to furnish the exclusive bargaining representative with a complete list of the names and addresses of the public employees in the bargaining unit in a specified format at least once each month (but within 10 days of the date of hire for new employees). Employers must still provide this information upon request of the bargaining unit as is the case under existing law.
- Prohibit employers from discouraging employees or applicants from becoming or remaining union members or authorizing dues deductions and from otherwise interfering with the relationship between employees and their exclusive bargaining representative.
- Require employers to refer all inquiries about union membership to the exclusive bargaining representative, with certain exceptions.
- Require employers to provide bargaining units with access to employees within the workplace.

With the exception of an employee's exclusive bargaining representative or for purposes of conducting public operations or business, the new law would also prohibit public employers from disclosing specific personal information with respect to employees, including:

- (1) the employee's home address (including ZIP code and county);
- (2) the employee's date of birth;
- (3) the employee's home and personal phone number;
- (4) the employee's personal email address;
- (5) any information personally identifying employee membership or membership status in a labor organization or other voluntary association affiliated with a labor organization or a labor federation (including whether employees are members of such organization, the identity of such organization, whether or not employees pay or authorize the payment of any dues or moneys to such organization, and the amounts of such dues or moneys); and
- (6) emails or other communications between a labor organization and its members.

If signed by the Governor, the legislation would amend the Freedom of Information Act to specifically exempt this information from disclosure in response to a FOIA request.

As soon as practicable after receiving a request for personal information, the employer must provide a written copy of the request (or a written summary of any oral request) to

the employee's exclusive bargaining representative. If the employee does not have a bargaining representative, then the employer must provide the request to the employee. Within five business days of responding to such a request, a copy of the employer's response must also be provided to these individuals.

The new law also contains provisions concerning the collection of union dues.

If signed by the Governor, the new law takes effect immediately.

January Legislative Update

GOVERNOR'S HIGHLIGHTS:

In late December Gov. J.B. Pritzker told reporters that his **legislative priorities** for the 2020 Spring legislative session include "tackling" **pensions, early child education, criminal justice reform and health care** next year as well as helping address legislative changes for a **Chicago casino**. The General Assembly returns Jan. 28th for the start of the next legislative session.

Gov. Pritzker **signed** the following legislation of interest in December:

- **SB222 (Munoz/Rita)** allows the Illinois Gaming Board and Illinois State Police to submit **fingerprints of sports wagering applicants** to the FBI for review.
- **SB670 (Munoz/Jones)** requires **corporate governance** reporting for **insurers**.
- **SB177 (Harris/Davis)** establishes the **Illinois Works Jobs Program**, which makes \$25 million available to community-based organizations to recruit new apprentices to work on construction projects. Under the new law, apprentices will comprise 10% of the labor force on all projects costing \$500,000 or more. Funding for the Illinois Works Jobs Program will come from the \$45 billion capital plan.

Also of note, Gov. Pritzker signed legislation to **combine** over 500 local **downstate police and fire pension** systems into **two statewide funds**. **SB1300 (Castro/Hoffman)** takes effect Jan. 1, 2020.

The Governor also announced changes to the state's **child care assistance program**. The child care **reimbursement rates** for all center and home-based providers will **increase by 5%**. The state will also **increase** its investment in **early childhood workforce training** by **\$3 million**. The Governor also created the **Commission on Equitable Early Childhood Education and Care Funding** to evaluate the state's ECEC system and establish **funding goals and funding mechanisms** to provide equitable access to high-quality early childhood education and care for all children birth to five.

The **Illinois Environmental Protection Agency's Office of Energy** has announced up to **\$1 million** of grant funding available for **energy efficiency upgrades at public wastewater treatment plants**. Under the Wastewater Treatment Plant Energy Efficiency Program, grant awards ranging from \$5,000 to \$500,000 will aim to reduce energy usage for Illinois municipalities. Application materials are available at Illinois EPA's [Office of Energy webpage](#). The application period closes at midnight on February 28, 2020.

CANNABIS ROUNDUP:

In December, the **Illinois Department of Financial and Professional Regulation** filed **emergency rules** for licensees to be selected by lot when there are two or more applicants with tied high scores for the last remaining license or licenses in a particular Bureau of Labor Statistics region. The rules also confirm that an unsuccessful applicant does not have a right to administrative review of that result. The Cannabis Regulation and Tax Act directs IDFP to award up to 75 conditional adult use dispensing organization licenses by May 1, 2020. A set number of licenses will be awarded to each BLS region. The emergency rules can be found [here](#). The **Illinois Department of Financial and Professional Regulation** announced **four additional "Same Site"** adult use cannabis licenses, which will allow existing medical cannabis dispensaries to obtain an adult use dispensing license. Amends the Boundary Changes Article of the School Code. With respect to a county with a population in excess of 3,000,000 in which (i) affected students reside in a municipality with a population not exceeding 15,000, (ii) the elementary school district serving the property to be detached sends students to 2 or more high school districts, (iii) the annexing school district has a high school located in the municipality, (iv) the farthest point from the detached property to the new school is less than 4 miles, and (v) the detachment and annexation will put the entire municipality into a single high school district, provides that a hearing panel (rather than the trustees of schools of the township) shall have and perform all powers, duties, and responsibilities required under the Article to be exercised and performed by a regional board of school trustees; the petition for boundary change may be filed by a number of legal resident voters equal to at least 50% of the number of legal resident voters in the affected territory who voted in the last presidential election; and if there are no legal resident voters, the petitioners may deliver the petition by regular mail to the last taxpayer of record of real estate instead of by certified mail, return receipt requested, to the owner

of record. Allows the hearing panel to compare school and district report cards and to consider the community of interest of the petitioners and their children. Effective immediately.

Makes a conforming change in the Conversion and Formation of School Districts Article. Effective immediately.

New Laws Effective January 1, 2020

- HB 00002 (Health) - Amends the Medical Patient Rights Act to delineate 21 rights of women during pregnancy and childbirth.
- HB 00026 (Higher Education) - All students in top 10% of their school's GPA must be accepted to NIU, SIU, WIU, EIU, provided other criteria met.
- HB 00037 (Education) - Allows nonpublic school students to be awarded the State Seal of Biliteracy, which is currently only granted to public high schools students.
- HB 00038 (Criminal Law) - Enhances penalties for crimes committed in places of worship. States that a person commits aggravated assault or aggravated battery when he or she commits an assault or battery in a church, synagogue, mosque, or other building, structure, or place used for religious worship.
- HB 00088 (Civil Law) - Lowers the annual interest rate on consumer debt judgments, valued at or below \$25,000, from 9% to 5%.
- HB 00094 (Criminal Law) - Makes individuals serving a sentence for an offense committed before June 19, 1998 eligible for good time sentence credits for successful completion of a degree, substance abuse or other rehabilitation programming.
- HB 00105 (State Government) - Makes technical changes to clean-up the Fire Investigation Act by Illinois State Fire Marshal.
- HB 00124 (Public Safety) - Allows state trooper candidates to have 60 college credit hours in any discipline to qualify as opposed to two years of law enforcement studies.
- HB 00210 (Public Safety) - Creates the Tamms Minimum Security Unit Task Force to study using Tamms Minimum Security Unit as a vocational training facility for the Department of Corrections.
- HB 00250 (Revenue and Taxes) - Allows counties, other than Cook County, to combine their property tax sales with one or more contiguous counties.
- HB 00253 (Labor) - Removes Graduate Assistants (GAs) from the "student" classification, allowing them to be classified as employees, which grants them the same rights as other employees including the right to collectively bargain.
- HB 00254 (Education) - Requires all school districts to report teacher employment data including, but not limited to, the number of teachers employed by individual schools to the State Board of Education.
- HB 00269 (Labor) - Regarding enforcement of workers' compensation enforcement and penalties.
- HB 00331 (Public Safety) - Tamara Clayton Act. ISP, IDOT, Toll Authority to increase cameras along Cook County expressways. Any law enforcement agency with jurisdiction over Cook County expressways may use images to investigate firearm offenses and detect expressway hazards, but not petty offenses.
- HB 00344 (Human Services) - Creates the Authorized Electronic Monitoring in Community-Integrated Living Arrangements and Developmental Disability Facilities Act by authorizing the use of video or audio surveillance in a resident's room at the resident's own expense.
- HB 00347 (Seniors) - Adds other actions to the definition of abuse against the elderly. These acts include assault, aggravated assault, battery, and aggravated battery.
- HB 00355 (Education) - Providers of professional development trainings may include inclusive practices in the classroom that examines instructional and behavioral strategies that improve academic and social-emotional outcomes for all, with or without disabilities.
- HB 00386 (Criminal Law) - Requires correctional entities to publish a report on their use of evidence-based practices to set conditions of local supervision and mandatory supervised release, to be published annually on the DOC website.
- HB 00424 (Education) - Requires the State Board of Education to establish criteria for interpreters who attend an individualized education program meeting with parents.
- HB 00465 (Health) - Establishes regulations for Pharmacy Benefits Managers that operate in Illinois.
- HB 00808 (State Government) - Reduces the fee for original, renewal, and duplicated Illinois ID cards for individuals under 18 from \$10 to \$5.

- HB 00814 (Local Government) - Municipal officials may satisfy training requirements of the Open Meetings Act by in-person trainings sponsored or conducted by the Illinois Municipal League.
- HB 00831 (Human Services) - If DCFS gets a report of suspected abuse or neglect of a child who was receiving care in a hospital, including psychiatric hospitals, DCFS shall notify the Directors of DPH and HFS of the report. DPH licenses those facilities, HFS provides healthcare for those patients under Medicaid.
- HB 00840 (Environment and Energy) - Requires each nuclear power plant in IL to submit a copy of their decommissioning funding report to the Illinois Commerce Commission indicating the status of their federally mandated trusts which are to be put aside to cover the cost of decommissioning each of their nuclear plants.
- HB 00889 (Health) - Requires health insurers to cover long-term antibiotic therapy for people with a tick-borne disease.
- HB 00900 (Criminal Law) - Removes provision requiring incarcerated people to reimburse the DOC for the cost of their incarceration. "Pay to Stay."
- HB 00909 (Family) - Allows forensic interviewers to, without parental consent, electronically record interviews with children in protective custody who are under suspicion of being abused.
- HB 00938 (Local Government) - Changes the Municipal Code to allow the proceeds of a sales tax imposed by a non-Home Rule Municipality to be used for municipal operations through July 1, 2030, opposed to December 31, 2020.
- HB 01455 (Civil Law) - Requires disputes over the disposition of a decedent's remains to be resolved within 30 days.
- HB 01471 (Civil Law) - Creates Illinois Trust Code to consolidate existing statutes and common law practices on trusts into one single act.
- HB 01551 (Human Services) - Requires DCFS to accept a report as a child welfare services referral when a report is made by a mandated reporter and there is a prior indicated report of abuse or neglect and a prior open service case involving any member of the household.
- HB 01553 (Civil Law) - Changes various acts to allow for civil courts to make findings when determining the custody determination of a minor.
- HB 01557 (State Government) - Requires the Secretary of State to provide a pamphlet or post information informing customers of the availability of literacy and English as a second language classes.
- HB 01579 (Criminal Law) - Expands the offense of disorderly misconduct to cover threats against schools that are made online or do not specifically mention a bomb.
- HB 01583 (Criminal Law) - Changes the Code of Criminal Procedure so if an arrest warrant is requested electronically has a simultaneous video and audio transmission between the requesting party and a judge, the judge may issue an arrest warrant based upon a sworn complaint or testimony communicated in the transmission.
- HB 01652 (Human Services) - The Department of Financial and Professional Regulations (IDFPR) must designate one staff member as the Department's military liaison to ensure licensure requirements for service members' and their spouses are managed properly and efficiently.
- HB 01873 (Transportation) - Raises the mandatory fines for illegally passing a school bus from \$150 to \$300 for an initial violation and \$500 to \$1,000 for a future violation.
- HB 01876 (Transportation) - Allows a deputy and assistant fire chiefs to operate a vehicle with red or white oscillating lights.
- HB 02028 (State Government) - Increases the burial benefit for a fireman, State Police, or local law enforcement officer killed in the line of duty from \$10,000 to \$20,000.
- HB 02045 (Health) - Prohibits the Department of Corrections and the Department of Juvenile Justice from requiring a committed person to pay any co-pay for receiving medical or dental services.
- HB 02086 (Health) - Makes April Healthy Pet Month, to be observed by reviewing their pet's health needs and making arrangements with their veterinarians to enhance and extend their pet's quality of life.
- HB 02088 (Transportation) - Allows the Secretary of State (SOS) to issue Cold War license plates.
- HB 02119 (Transportation) - Allows the Secretary of State to issue United Nations Protection Forces license plates.
- HB 02121 (Transportation) - Changes the eligibility standards for individuals with a criminal conviction

applying for a bus driver license.

- HB 02126 (Veterans) - Authorizes K9's for Veterans to issue decals to promote awareness for veterans with PTSD.
- HB 02133 (Criminal Law) - Expands the definition of computer to include cloud-based networks.
- HB 02135 (Criminal Law) - Removes the statute of limitations for criminal sexual assault, aggravated criminal sexual assault, and aggravated criminal sexual abuse for all ages, not just those 18 and under.
- HB 02146 (Health) - Requires UIC School of Public Health and IDPH to convene a working group to come up with policy recommendations relating to the health of Illinois residents.
- HB 02154 (Human Services) - Creates the Children and Youth Adult Mental Health Crisis Act, which will restructure the Individual Care Grant/Family Support Program for children and young adults with high mental health need regardless of type of insurance coverage.
- HB 02156 (Consumers) - Makes it unlawful for any business to offer consumers at retail a rebate card that charges dormancy fees and other fees after issuance of the card.
- HB 02160 (Insurance) - Directs the Department of Insurance and Department of Healthcare and Family Services to create a uniform, electronic prior authorization form for processing prescription drug benefits on or after July 1, 2021.
- HB 02165 (Education) - Requires students to take three years of math to graduate high school but provides local school districts with flexibility over required classes to remove barriers to graduation for some students.
- HB 02176 (Civil Law) - Cracks down on notary fraud often targeted at Spanish speaking communities by increasing fines and strengthening posting requirements.
- HB 02189 (Consumers) - Prohibits companies that provide direct-to-consumer commercial genetic testing from sharing any test results or other personally identifiable information with any health or life insurance company without the written consent from the consumer.
- HB 02237 (Higher Education) - Establishes Illinois Higher Education Savings Program and creates the Illinois Higher Education Savings Program Fund, which will deposit \$50 into college savings account for every child born or adopted in Illinois after December 31, 2020, for the purpose of expanding access to higher education.
- HB 02239 (Higher Education) - Allows both student trustees, from Edwardsville and Carbondale campuses, to be voting members of the Southern Illinois University Board.
- HB 02247 (Health) - Creates a community-based pilot program for persons with mental illness or persons at risk for mental health diagnosis in communities with high need or underutilization of mental health services.
- HB 02272 (Education) - Provides that contract schools with Chicago Public Schools are subject to the Freedom of Information Act (FOIA) and the Open Meetings Act.
- HB 02301 (State Government) - Requires union representatives or attorneys who have represented unions in workers compensation cases to be appointed to boards, commissions and panels that deal with workers compensation and related issues.
- HB 02304 (Labor) - Creates the Youth Training and Education in the Building Trades Program with the Department of Human Services and the Illinois Housing Development Authority to train at-risk youth for careers in the building trades.
- HB 02308 (Criminal Law) - Provides that in the event a defendant is unable to post bond, the court may impose a no contact provision with the victim or other interested party that shall be enforced while the defendant remains in custody.
- HB 02309 (Civil Law) - Provides that when various protective orders are filed against a person, they will not be made publicly available until the person they are regarding is served notice.
- HB 02315 (Transportation) - An initiative of the Secretary of State which will bring the SOS into compliance with federal regulation, streamlines driver's license services, and corrects prior drafting errors.
- HB 02408 (Cybersecurity) - Creates the Removal of Private Compromising Images Act, which creates a private right of action against individuals for intentionally posting a compromising image of another online or the owners or operators of a website hosting the images.
- HB 02433 (Health) - Requires every hospital to ensure it has the proper instruments available for taking a pregnant woman's blood pressure and requires the Department of Public Health to adopt rules to implement

the requirement.

- HB 02444 (Criminal Law) - Court will consider circumstances involving unnecessary harm to children by separation from parents during pre-trial detention or incarceration as factors of release.
- HB 02460 (State Government) - Allows state agencies and boards to adopt sustainable investment policies.
- HB 02492 (Business) - Authorizes the International Association of Machinists and Aerospace Workers and its Local Lodge 701 to issue decals for the universal special license plate.
- HB 02505 (Agriculture & Natural Resources) - Defines local farm and food products as grown in Illinois or processed and packaged in Illinois, using at least 1 ingredient grown in Illinois.
- HB 02512 (Higher Education) - Requires each public university to submit an annual report to the Board of Higher Education on the amount of tuition that undergraduate, degree-seeking students attending the university paid in the previous academic year.
- HB 02528 (Business) - Provides that a person operating a home-based business under an assumed name may list the county clerk and its address as the default agent for service of process, to include either a court order or police report.
- HB 02541 (Criminal Law) - Requires DOC and DJJ to provide a civics education program to incarcerated citizens who will be released in 12 months.
- HB 02557 (Labor) - Requires employers to obtain consent from potential employees being interviewed if the interview uses artificial intelligence analysis.
- HB 02591 (Local Government) - Amends the Illinois Police Training Act by making various changes hiring requirements for police officers.
- HB 02605 (Education) - Provides that if a speech language pathologist hold a regular State license he or she does not need to meet other requirements to be issued a professional educator license with a school support personnel endorsement for non-teaching.
- HB 02618 (Veterans) - Allows any veteran that has a service-related disability of 50% or more to obtain any military series license plate without a registration fee.
- HB 02650 (Public Safety) - Requires the Illinois Environmental Protection Agency, for a period of five years after the effective date of the bill, to prioritize a portion of capitalization (water) grant for supporting disadvantaged communities.
- HB 02665 (Health) - Allows a minor of 12 years of age or older to give consent for health care services or counseling related to the prevention, rather than only for diagnosis and treatment, of sexually transmitted diseases.
- HB 02669 (Transportation) - Removes the registration requirements for specific farm wagons.
- HB 02670 (Economic Development) - Reduces the restrictions on opening a business for those with past criminal offenses and defines the terms and provides flexibility to various state departments to review the circumstances around past offenses.
- HB 02691 (Higher Education) - Permits transgender students and noncitizen students to be eligible for State financial aid at all institutions of higher education in the State of Illinois.
- HB 02699 (Civil Law) - It increases the coverage of the Mortgage Act to include persons authorized by the mortgagor, grantor, heir, legal representative, or assign.
- HB 02700 (Pensions) - Requires Central Management Services to identify a situation where a Teacher's Retirement System recipient overpaid for health insurance and refund the overpaid amount as soon as practicable.
- HB 02720 (Higher Education) - Extends the deadline for universities to send their financial reports detailing the previous fiscal year's revenues and expenditures to the Illinois Board of Higher Education, the Governor, and the General Assembly from 120 days to 150 days following the end of the fiscal year.
- HB 02722 (State Government) - Provides that contractors with state contracts greater than \$50,000 shall deliver a surety bond and file it with the State to ensure the completion of the contract and all related material and subcontractor costs.
- HB 02737 (Agriculture & Natural Resources) - Allows a Soil Water and Conservation District to provide best management practices regarding soil health and soil health improvement.

- HB 02767 (Health) - Requires the IL Law Enforcement Training & Standards Board to create, develop, or approve an in-service course addressing issues of officer wellness and suicide prevention.
- HB 02802 (Education) - Provides if a vacancy occurs and members of the board fail to fill the vacancy within 60 days, the regional superintendent of schools shall fill the vacancy within 30 days. This only applies to those school boards that form a district with a population of less than 500,000.
- HB 02822 (Education) - Requires the State Board of Education to collect data for its annual school report card on workplace learning experiences.
- HB 02832 (Civil Rights) - Dedicates the month of April of each year as Sikh Awareness and Appreciation Month.
- HB 02847 (Insurance) - Prohibits insurance companies from discriminating against living organ donors, makes it unlawful for an employer to retaliate against an employee for requesting or taking a leave to donate an organ, and requires the Secretary of State to create an organ and tissue donor registry.
- HB 02852 (Higher Education) - Requires public universities that offer a competency-based learning program to notify a student if he or she becomes eligible for the program.
- HB 02856 (Transportation) - Requires the Secretary of State to implement an Electronic Title System by July 1, 2021 that will permit a lienholder to perfect, assign, and release a lien.
- HB 02895 (Health) - Requires hospitals caring for pregnant and postpartum women to train for related medical issues and implicit bias training. DPH must support statewide perinatal quality improvement initiative, reduce racial and ethnic disparities.
- HB 02896 (Health) - Creates the Diversity in Health Care Professions Task Force, and provides objectives and priorities, requires it to prepare a report for the Governor and the General Assembly by December 1, 2020 and annually thereafter.
- HB 02897 (Health) - Requires DPH to investigate and apply for federal funding opportunities to support maternal mental health and requires DPH to file a report with the General Assembly on or before January 1, 2021 about its efforts. Sunset: 1/1/2022.
- HB 02934 (Civil Law) - Provides that service under the Juvenile Court Act may be satisfied by leaving a copy of a summons and petition at the individual's usual place of abode with a family member or a person that is residing there.
- HB 02935 (Civil Law) - Allows for the court to vacate an appointment of counsel in a proceeding under the Juvenile Court Act.
- HB 02983 (Family) - Creates the Youth Homelessness Prevention Subcommittee under the Governor's Cabinet on Children and Youth.
- HB 02992 (Civil Law) - Makes changes to each of the five Business Organizations Acts for the Secretary of State.
- HB 03014 (State Government) - Requires the Department of Agriculture to rename the Ethnic Village exhibit at the Illinois State Fair to the Village of Cultures.
- HB 03039 (Health) - Amends the Public Aid Code and requires the Department of Human Services (DHS) to send notice of terminated Medicaid assistance to the long-term care facility where the resident resides, in addition to notifying the resident.
- HB 03040 (Health) - Amends the Public Aid Code to require that if an individual has transferred from one long-term care (LTC) facility to another LTC facility, the individual Medicaid eligibility must be sent to the LTC facility where the individual resides and to that individual.
- HB 03065 (Seniors) - Requires the Adult Protective Services Act providers to conduct interviews of the eligible adult's family members, neighbors, and friends when conducting any investigation concerning a report of suspected abuse, neglect, financial exploitation, or self-neglect of an eligible adult.
- HB 03069 (Human Services) - Requires any facility licensed under the Community-Integrated Living Arrangements Licensure and Certification Act to notify the Department of Human Services when emergency calls are made from the facility.
- HB 03082 (Pensions) - Requires Central Management Services to automatically enroll new members of State Retirement Systems into the deferred compensation plan and deduct 3% of gross compensation each pay period.

- HB 03084 (Economic Development) - Requires DCEO to work with the General Assembly, to complete an assessment of its current practices related to its marketing programs administered and the extent to which it assists Illinois residents in the use of programs offered.
- HB 03092 (Agriculture & Natural Resources) - Requires state agencies, where appropriate, to give preference to using native prairie and forage plants to benefit pollinators, including but not limited to, honey bees and monarch butterflies.
- HB 03097 (Health) - Requires the Department of Healthcare and Family Services to develop a pharmaceutical education program for prescribing physicians under Medicaid
- HB 03113 (Insurance) - Requires insurance providers to cover skin cancer screenings without any cost-sharing requirements.
- HB 03168 (Criminal Law) - Requires that a pre-sentence report must include information concerning a defendant's eligibility for a sentence to an impact incarceration program administered by the Department of Corrections.
- HB 03216 (Veterans) - Creates a new process for issuing veteran's driver's license and ID cards. Secretary of State will issue the veteran license or ID and then send the documentation to DVA to confirm that the individual meets the right criteria.
- HB 03217 (State Government) - Creates the Asian American Family Commission.
- HB 03247 (Health) - Creates the Parkinson's Disease Public Awareness and Education Program to promote public awareness of Parkinson's disease and the value of early detection and possible treatments and sets forth requirements for the program.
- HB 03269 (Business) - Makes changes to how car dealers' agents may transport vehicles, background checks on remittance agents.
- HB 03299 (Human Services) - Requires that individuals admitted to developmental disability facilities and receiving habilitation shall have access to sex education, related resources, and treatment planning that supports their rights to sexual health and freedom from sexual exploitation and abuse.
- HB 03320 (Education) - Allows people who made complaints during the 2016-2017 and 2017-2018 school years for delays and denials of special education 2 more years to file complaints.
- HB 03331 (Human Services) - Changes to the types of assistance offered to households to prevent homelessness by adding the payment of rent or mortgage to the types of assistance available
- HB 03390 (Environment and Energy) - Changes the Animal Welfare Act and requires dog or cat kennel operator buildings to be equipped with a fire sprinkler or fire alarm system if the establishment is not staffed at all times.
- HB 03396 (Public Safety) - Changes the Stalking No Contact Order Act to when an emergency stalking no contact order is granted on a court holiday or evening, the court will immediately file a certified copy with law enforcement officials who maintain State Police records.
- HB 03404 (Health) - Requires public colleges and universities to provide information to students on all mental health and suicide prevention resources available at the university.
- HB 03405 (Labor) - Provides that gratuities to employees are the property of the employees and may not be retained by an employer.
- HB 03435 (Insurance) - Requires insurers to cover medically necessary epinephrine injectors for persons under 18 years old.
- HB 03437 (Transportation) - Authorizes DHS to issue "Developmental Disabilities Awareness" decals for the universal special license plate.
- HB 03440 (Health) - Allows consumers to use personal containers to fill or refill bulk food, provided that the dispensers used prevent the direct handling of the food and the containers are clean and sanitary.
- HB 03468 (Health) - Requires all health care facilities to make reasonable efforts to have the closed captioning feature on a television activated at all times in a common area provided for use by the general public or in a patient's room.
- HB 03471 (Health) - Requires insurance companies to provide coverage for cardiopulmonary monitors for minors.

- HB 03487 (Insurance) - Requires hospitals to post information on how to enroll in health insurance through the Illinois health insurance marketplace.
- HB 03498 (Civil Rights) - Ends the statute of limitations for the prosecution for female genital mutilation if the victim is under 18 years of age at the time of the offense.
- HB 03503 (Seniors) - Requires insurers to offer optional coverage for hearing instruments and any related services for all individuals 65 years old and older when so prescribed by a hearing care professional.
- HB 03509 (Health) - Requires certain health insurance companies to cover donated human breast milk for infants under the age of up to 12 months or older if deemed medically necessary.
- HB 03511 (Health) - Directs the Department of Human Services to develop educational materials for health care professionals and patients about maternal mental health conditions.
- HB 03534 (State Government) - Requires the Secretary of State to allow applicants to choose between "male", "female" or "non-binary" when designating the applicant's sex on their driver's license or ID card.
- HB 03550 (Education) - Requires sex education course material and instruction in grades 6 through 12 to include an age-appropriate discussion on the meaning of consent.
- HB 03554 (State Government) - Allows the state to send EMS license renewal notices via email in addition to regular mail.
- HB 03575 (Cybersecurity) - Creates the Blockchain Technology Act which provides for permitted uses and limitations of blockchain technology in transactions and proceedings and 2) prohibits local governments from imposing taxes or fees and certain restrictions on the use of blockchain.
- HB 03580 (Criminal Law) - Amends the Unified Code of Corrections to provide that Certificates of Good Conduct may relieve eligible offenders of any bar to occupational licensing or housing.
- HB 03584 (Criminal Law) - Provides a crime victim the right to register with the Prisoner Review Board's victim registry and to submit a victim impact statement to the Board for consideration at hearings or executive clemency hearings.
- HB 03587 (Family) - Amends the Adoption Act to make various changes to post-placement and post-adoption support services.
- HB 03604 (Local Government) - Allows the University of Chicago to sell liquor at its new hotel and conference center, preempting a 1950's referendum for a dry campus.
- HB 03659 (Education) - Charter School's board of directors must have a parent or guardian member. Also, all voting board members must receive training to ensure members understand their roles and responsibilities.
- HB 03663 (Labor) - Provides a framework and clarity of what a worker co-operative is and the benefits and rights of those that operate one.
- HB 03671 (Housing) - Allows landlords to request documentation when allowing a service animal on the premises where pets are generally prohibited.
- HB 03701 (Criminal Law) - Provides that CMS is not required to verify State Board of Education licenses to jobs seekers within DJJ. Removes aftercare release from the time period in which a person could have received an education. Commitments to DJJ that are automatically terminated and report to Gov.
- HB 03704 (Criminal Law) - Provides that the Department of Juvenile Justice shall establish and provide transitional and post-release policies and procedures that promote family engagement, visitation and programming.
- HB 03711 (Health) - Requires all public restrooms in a public building to have a baby changing facility.
- SB 00024 (Transportation) - Requires freight trains to be operated by a crew of at least 2 people.
- SB 00069 (Seniors) - Tightens up statutes to ensure those who commit crimes against elderly and disabled persons are held accountable.
- SB 00075 (Civil Law) - Sexual harassment, discrimination and ethics omnibus. Makes numerous changes to employment and civil rights laws to ensure that workers who experience sexual harassment and discrimination have a meaningful remedy under Illinois law.
- SB 00086 (Public Safety) - Clarifies that people cannot stream videos on a cell phone while they are driving.
- SB 00087 (Public Safety) - Bans tinted headlights from being installed on cars.
- SB 00090 (Local Government) - Creates a new process for dissolving drainage districts via resolution or

ordinance if the municipalities within the region of the drainage district and the county are in agreement; certain requirements need to be met.

- SB 00104 (Transportation) - Sets requirements to ensure prompt payment of a subcontractor.
- SB 00111 (Insurance) - Raises the age of eligibility for certain individuals diagnosed with autism spectrum disorder or a developmental disability to receive coverage for anesthetics provided in conjunction with dental treatment from 19 to 26.
- SB 00117 (Education) - Requires a student to be notified before any school student record is destroyed or information is deleted.
- SB 00131 (Agriculture & Natural Resources) - Requires cats to receive a rabies vaccination with a tag and certification. The requirement does not apply to feral cats unless the feral cat is taken to the vet for sterilization.
- SB 00147 (Family) - A certificate of employment will not be issued to a child performer under the age of 16 without determining that a trust account has been established for the minor.
- SB 00156 (State Government) - Allows the Department of Corrections to give inmates access to career building and job search websites.
- SB 00161 (State Government) - Creates a new Worker Protection Unit within the Attorney General's office, which would be empowered to enforce employment laws.
- SB 00162 (Health) - Mandates insurers to cover diagnostic mammograms and makes changes to the coverage mandate for comprehensive ultrasound screening.
- SB 00172 (Higher Education) - Allows candidates for student trustee at the University of Illinois to run if they prove their residence of Illinois for 6 months and provide a valid driver's license, I.D. card or voter registration card.
- SB 00182 (Health) - Requires the Department of Public Health to study the feasibility of creating a statewide registry of advance directives.
- SB 00190 (State Government) - Attempts to assist individuals with disabilities who want to work for the State of Illinois by requiring CMS send the Successful Disability Opportunities List to any agency that is looking to hire.
- SB 00195 (Business) - The purposes of escrows, settlements or closings, "good funds" may be in the form of a check drawn on the fiduciary trust account of a title insurance company, a title insurance agent or an independent escrowee.
- SB 00205 (State Government) - Extends the sunset date for bonding authority without referendum for the Metropolitan Water Reclamation District to December 31, 2034.
- SB 00218 (Family) - The Department of Children and Family Services when involving children under its care will request that the State's Attorney file a petition or motion to terminate parental rights of a parent that has been criminally convicted of sexual crimes against children.
- SB 00220 (Civil Law) - Provides that the IDHR can determine on a case-by-case basis whether to hold a fact-finding conference in housing cases and requires training in housing discrimination. The AG has 30 days to begin a civil action after IDHR has entered an administrative closure order on a case.
- SB 00397 (Civil Law) - Makes technical changes to the Court Reporters Act.
- SB 00399 (Civil Law) - Allows addresses to be omitted when documents are submitted to the courts during a child custody hearing if disclosure would risk abuse of the party or a family member.
- SB 00416 (Criminal Law) - Provides that it is an aggravated factor in sentencing if a defendant has been found guilty of an administrative infraction related to public indecency or sexual misconduct while in jail.
- SB 00455 (Education) - Allows a school nurse or school administrator to administer or supervise self-administration of medical cannabis infused products to a student who is a registered qualifying patient of the Medical Cannabis Pilot Program.
- SB 00459 (Health) - Requires the instruction on mental health and illness included within the State of Illinois' Comprehensive Health Education Program to evaluate the multiple dimensions of health by reviewing the relationship between physical and mental health so as to promote health, well-being and human dignity.
- SB 00534 (Labor) - Creates the Bureau on Apprenticeship Programs within the Illinois Department of Labor and creates an advisory board of 12 legislators (three from each caucus, appointed by the caucus leader).
- SB 00556 (Civil Rights) - Requires single-occupancy restrooms in a public location to be identified as all-gender and designated for use by no more than one person at a time or for family or assisted use and requires

exterior signage that marks the restroom as a restroom and does not indicate any specific gender.

- SB 00584 (Local Government) - Makes changes to the Metro-East Sanitary District Act including the residency requirements for commissioners and the removal process.
- SB 00640 (Local Government) - Clarifies language to the Public Aid Code authorizing townships to provide and administer food pantry programs as part of their general assistance programming.
- SB 00651 (Consumers) - Prevents alternative electric and gas suppliers from converting participants in both LIHEAP and PIPP from their current public utility provider to the alternative supplier, unless done so by an approved program.
- SB 00725 (State Government) - Repeals the sunset date on the Open Operating Standards Act, which established a single data portal (data.illinois.gov) for all agencies to use to publish information for public review.
- SB 00727 (State Government) - Creates the Native American Advisory Council that will be compiled by members of various state agencies. The goal for the council is to increase the number of Native American employees and Native Americans in managerial positions at state agencies.
- SB 00728 (Transportation) - Creates the DUI Prevention and Education Commission and Fund which will distribute grants to crash victims, impaired driving prevention programs, law enforcement support and other DUI programs.
- SB 00765 (Local Government) - Allows a township to appoint a non-resident highway commissioner.
- SB 00944 (Veterans) - Allows for a special license plate for veterans with disabilities to be affixed to motorcycles.
- SB 00946 (Transportation) - Allows the Illinois Department of Human Services to issue pediatric cancer awareness decals for universal special license plates.
- SB 01041 (Revenue and Taxes) - When a lessee is liable for the payment of property taxes, a taxing district owns the property, and the taxes remain unpaid 60 days after the second installment due date, then the State's Attorney may bring suit against the lessee. Only applies to DuPage County.
- SB 01114 (Local Government) - Would allow a county to bring an action for immediate injunctive relief, without bond, if the county finds an imminent hazard to public health or safety from an unfit condition, such as unhealthy accumulation or concentration of hazardous or unhealthy substance or materials.
- SB 01133 (Business) - Changes the Acupuncture Practice Act to provide title protection for Chinese Herbology.
- SB 01134 (Civil Law) - If a notice of foreclosure cannot personally be served so a notice of foreclosure is served by publication, it is the duty of the clerk to mail to each defendant listed on the filed Affidavit for Service by Publication a copy of the published notice by first-class mail within ten days.
- SB 01167 (Higher Education) - Provides that ISAC shall receive and consider applications for an adult vocational community college scholarships (not to exceed \$2,000/student) for anyone over the age of 30 and who is unemployed but actively searching for employment.
- SB 01191 (Civil Law) - A person who wishes to change his or her name after a divorce does not have to provide notice by publication of the changed name or file a petition to change their name.
- SB 01214 (Health) - Requires the Department of Public Health to make training materials available to ensure those who draw blood from individuals with intellectual and developmental disabilities are trained in the most current method of drawing blood.
- SB 01239 (State Government) - Requires the DCFS to immediately refer reports when it has received reports alleging the abuse or neglect of a child by a person who is not the child's parent.
- SB 01250 (Education) - Schools must allow a student diagnosed with a pancreatic insufficiency to self-administer/self-manage his or her pancreatic enzyme replacement therapy if the parent/guardian provides the school with written authorization.
- SB 01256 (Transportation) - Prohibits a diesel truck from idling for more than a total 10 minutes within an hour if the vehicle is within 200 feet of a residential area.
- SB 01264 (Pensions) - Updates the Revised Uniform Unclaimed Property Act so that it does not apply to any annuity, pension, or benefit funds held in a fiduciary capacity by or on behalf of a retirement system.
- SB 01294 (Criminal Law) - Changes the Criminal Code of 2012 concerning identity theft to use the term "personal identifying information", rather than "personal identification information."

- SB 01343 (Transportation) - Allows an extreme heavy duty tow and recovery vehicle to travel to and from the scene of a disabled vehicle if the towing service has obtained a permit for the vehicle.
- SB 01377 (Insurance) - Adds an additional reason for the Director of Insurance to reject a plan of division of an Illinois Domestic Stock Company.
- SB 01378 (Civil Rights) - Prohibits anyone to be excluded from jury service on the basis of sexual orientation.
- SB 01381 (Transportation) - Removes the Class III highway designation from the Vehicle Code and requires local governments to report to IDOT any routes from which trucks are prohibited from traveling.
- SB 01392 (Environment and Energy) - Requires the Prairie Research Institute to conduct a study concerning microplastics and any threat microplastics may pose to human health and the environment.
- SB 01418 (Criminal Law) - Amends the Bi-State Development Agency Act and limits the number of Bi-State board members from counties without light-rail service to one member, and replaced by an appointee from the county with light-rail service.
- SB 01429 (Civil Rights) - States that evidence of a person's immigration status is inadmissible in a civil proceeding unless it is essential to prove an element of case or is voluntarily given by the person.
- SB 01456 (Revenue and Taxes) - Provides that tax-exempt property used for parking in Chicago may lose that tax exemption for any part of the property not used for parking.
- SB 01460 (Education) - Prioritizes teachers in underfunded school districts when distributing funds for the Teaching Excellence Program.
- SB 01464 (Civil Law) - Outlines the timeline for when a funeral pre-need trust fund is considered abandoned and authorizes the transfer of presumably abandoned pre-need trust amounts to care funds held by the cemetery.
- SB 01495 (Civil Law) - If a company fails to provide information as demanded under law, then the person entitled to the request may file an action to compel a company to provide the information and the company may be liable for court costs. Overrules *Dass v. Yale* 2013 IL App (1st) 122520.
- SB 01496 (Public Safety) - Increase the maximum penalty for hitting a construction worker to \$25,000 (Currently \$10,000).
- SB 01506 (Health) - Providers of mammography services must notify patients of dense breast tissue and recommend follow-up testing in a mammography report if a patient's mammogram demonstrates dense breast tissue.
- SB 01507 (Civil Law) - Creates the Civil Remedies for Nonconsensual Dissemination of Private Sexual Images Act, which allows victims of revenge porn to recover economic, non-economic, and punitive damages.
- SB 01525 (Human Services) - Requires DCFS to provide eligible youth with an apprenticeship stipend to cover the costs associated with entering and sustaining through an apprenticeship.
- SB 01526 (Civil Law) - Provides that every count in every complaint must request specific remedies the party believes it should receive from the court.
- SB 01529 (Environment and Energy) - Provides that delivery of renewable energy credits can be delayed until June 1, 2022, if the delay in establishing an operating connection with the applicable transmission is due to the distribution providers or unforeseen circumstances.
- SB 01558 (Gaming) - Allows Rockford to impose a \$250 per year fee on video gaming terminals.
- SB 01568 (Health) - Changes when coroners are required to preform autopsies on children aged 2 years or younger who die suddenly to 1 year or younger.
- SB 01580 (Local Government) - Allows counties to regulate businesses that involve nudity and sexual activities.
- SB 01583 (Criminal Law) - Warrants expire after 10 years in cases where an offender is in violation of probation, conditional discharge, or supervision for theft, retail theft, or possession of a controlled substance.
- SB 01599 (Criminal Law) - Requires a business that publishes criminal record information publicly must change any error within 5 business days of being notified of the error; failure to do so is a violation of the Consumer Fraud and Deceptive Business Practices Act.
- SB 01601 (Education) - Requires that, beginning with the 2020-2021 school year, current courses in U.S. history for K-12 students must also include instruction on the history of Illinois.
- SB 01609 (Criminal Law) - Increases the daily fine credit awarded to those incarcerated for a bailable offense and against whom a fine is levied on conviction, but are unable to post bail, from \$5 to \$30. An amendment keeps original bill and makes a change to Act to limit application to fines only.

- SB 01610 (Criminal Law) - Amends the Criminal Code to allow a defendant to withdraw their guilty plea within two years of a conviction if a judge failed to advise the defendant that a guilty plea could affect their immigration status. These provisions apply to defendants arraigned after the effective date of this Act.
- SB 01624 (Cybersecurity) - Requires companies that collect personal information concerning Illinois residents report data breaches affecting more than 500 Illinois residents to the Attorney General.
- SB 01651 (Local Government) - Expands a Forest Preserve District's ability to grant licenses and easements to also include licenses and easements for renewable energy resources.
- SB 01658 (Education) - Requires ISBE to award grants, subject to appropriation, to school districts to support school safety and security.
- SB 01694 (Education) - Provides that a high school may include in its curriculum a unit of instruction on workplace preparation studies that cover legal protections in the workplace, including protections against sexual harassment and racial discrimination.
- SB 01702 (Health) - Allows advanced practice psychiatric nurses to complete certificates for commitment and authorize restraint and seclusion for patients.
- SB 01712 (Local Government) - Exempts credit card, bank account and other confidential account numbers from FOIA requests.
- SB 01715 (Health) - Allows pharmacists to administer mental health drugs to patients via injection.
- SB 01726 (Health) - Creates the full-time position, Dementia Coordinator, within the Department of Public Health to oversee the implementation of the Illinois Alzheimer's Disease State Plan.
- SB 01731 (Education) - Allows school districts to use the Illinois Mental Health First Aid training program to satisfy the requirement for teachers to receive mental health training.
- SB 01743 (Human Services) - Requires DCFS to develop and implement a feedback survey for foster children who have aged or are aging out of the program.
- SB 01744 (Human Services) - Requires the Department of Corrections (DOC) to screen inmates prior to release for Medicaid eligibility.
- SB 01750 (Criminal Law) - Creates an aggravated factor in cases where the guilty party left the scene of an accident where a death occurred if they were under the influence of drugs, alcohol, or using an electronic device. Prosecution must prove the defendant exceeded the legal limit at time of accident.
- SB 01778 (Human Services) - Reorganizes the list of individuals who are required to immediately report to the Department of Children and Family Services when they have reasonable cause to believe that a child may be abused or neglected. Also requires training for mandated reporters.
- SB 01780 (Civil Law) - Creates a civil rights violation for any person engaged in a real estate transaction that because of unlawful discrimination, familial status, or an arrest record does not act in good faith.
- SB 01798 (Education) - Requires each school district to create, maintain, and implement an age-appropriate policy on sexual harassment that must be included in the district's student code of conduct handbook.
- SB 01806 (State Government) - Provides clean up language regarding local government accounting standards.
- SB 01847 (Environment and Energy) - Requires the IEPA to provide notice when a permit is required under the Environmental Protection Act to construct a new facility to the state senator and state representative of the district where the construction is to occur.
- SB 01862 (State Government) - Clarifies that vehicles need to slow down, change lanes and proceed with caution when approaching disabled vehicles or emergency vehicles on the side of the highway. Increases fines and penalties associated with breaking Scott's Law.
- SB 01888 (Higher Education) - Allows student applicants in a social work master's program to sit for the authorized examination in the final semester of the program, rather than after they receive their degree.
- SB 01894 (State Government) - Allows children and stepchildren of police officers or firefighters who have died in the line of duty to be issued deceased police officer or firefighter license plates.
- SB 01899 (Labor) - Delays what is known as the "speed bump" until 2022, which would decrease unemployment benefits and increase unemployment taxes on employers.
- SB 01915 (Public Safety) - Restructures the rights, powers, and duties of the State Police for more efficient management.

- SB 01917 (Local Government) - Allows local law enforcement associations to get licenses for raffles and poker runs.
- SB 01919 (Higher Education) - Creates the 21st Century Employment Grant Program to support manufacturing, healthcare and innovative technology training programs at community colleges and high schools.
- SB 01993 (Transportation) - Removes language stating that 16,000 lb diesel-powered vehicles operating as an interstate carrier of property are subject to diesel emission inspections.
- SB 02024 (Labor) - Requires the Department of Commerce and Economic Opportunity to conduct a study on the potential expansion of apprenticeship programs and publish it by June 1, 2020.
- SB 02027 (Environment and Energy) - Codifies the legislative recommendations of the Mahomet Aquifer Task Force and directs the Illinois Environmental Protection Agency to prioritize landfills overlying the Mahomet Aquifer for inspection.
- SB 02037 (State Government) - Establishes requirements for notary public remittance agents. The expanded requirements include being free of any administrative, civil or criminal complaints; a \$20,000 surety bond; and compliance with the Secretary of State notary application requirements.
- SB 02038 (Transportation) - Creates the Move Over Task Force and requires the Secretary of State to include "zipper merging" in the Illinois Rules of the Road.
- SB 02068 (Health) - Prohibits a public health district from regulating serving food in private residential household.
- SB 02085 (Insurance) - Mandates insurance coverage for benefits delivered through the psychiatric Collaborative Care Model
- SB 02087 (Human Services) - Creates a five-year pilot program for finding employment for individuals with disabilities, tasked with helping them find jobs and negotiating fair wages
- SB 02090 (Elections) - Establishes polling locations for those incarcerated but not yet convicted in Cook County jails and requires all local election authorities in other counties to coordinate VBM opportunities for those in the county jail.
- SB 02146 (Economic Development) - Requires Department of Commerce and Economic Opportunity to create a Clean Water Workforce Pipeline Program to prepare people for a career in water infrastructure.
- SB 02153 (State Government) - Changes the amount of time that an option to renew a lease must be published to the appropriate procurement bulletin from 60 calendar days to 30 calendar days.

SECTION 4: This resolution shall be in full force and effective from and after its passage and approval.




